The tender in sealed cover is hereby invited from bonafide parties for disposal of **Non seed paddy** at RRS, Chakdah Farm, BCKV.

RRS, Chakdah Farm, BCKV

1. Swarna Masuri	-	800 Kg	(approx) - Minimum rate Rs. 19.50/- per Kg.
2. Minikit	-	200 Kg	(approx) - Minimum rate Rs. 25/- per Kg.
(Minimum Amount for this tender Rs. 20,600/-)			

Intending parties may see the above mentioned non seed paddy in the said farms on any working day within 7.00 a.m. and 12.00 noon after making prior appointment with the concerned farm Incharge.

1. The rate must be ex-godown and without any container.
2. The rate to be submitted by the party must be written legibly both in figure and in words on a plain sheet duly singed along with detailed mailing address & Mobile No. & photo copy of photo ID proof
3. The entire cost of the above paddy as would be offered by the party and duly accepted by the authority will have to be paid to the concerned Incharge against demand draft or cash, within 7 days from the date of acceptance of the tender. Otherwise his "Earnest Money / Security deposit will be forfeited.
4. The non seed paddy must be collected by the party at his own cost.
