1. Swarna Masuri	-	800 Kg	(approx) - Minimum rate Rs. 19.50/- per Kg.
2. Minikit	-	200 Kg	(approx) - Minimum rate Rs. 25/- per Kg.

Intending parties may see the above mentioned non seed paddy in the said farms on any working day within 7.00 a.m. and 12.00 noon after making prior appointment with the concerned farm In-charge.

1. The rate must be ex-godown and without any container.

The entire cost of the above paddy as would be offered by the party and duly accepted by the authority will have to be paid to the concerned Incharge against demand draft or cash, within 7 days from the date of acceptance of the tender. 4. The non seed paddy must be collected by the party at his own cost.
5. The decision of the authority in any case is final.
