Sealed quotations are invited from the bonafide Parties/Persons for lease out of the low land areas (Water body) for fish farming at Purba Medinipur Krishi Vigyan Kendra, BCKV, Mulakhup, Dayaldasi, Purba Medinipur under the following terms and conditions. - Quotation should be submitted during the office hours at the office of the undersigned at Mulakhop, Dayaldasi, Purba Medinipur (except Saturday, Sunday & Holidays) within Ten (10) days of publication in the websites latest by 2.00 pm in last day.
- 2. Bidders have to submit the Application in theenclosed prescribed format.
- 3. The bidders should have to submit copies of Aadhar card, PAN Card with thequotation paper.
- 4. The bidprices should be above the minimum calculated (Base price) as per guideline for fixing Economic Lease Rent submitted by the ADF, Dept. of Fishery, Govt.of W.B. under amended L & LR Rules. 2012 vide Gazette Notification No. 5904-LP/1A-4/2012/dt. 12.11.2012 of the L & LR Deptt, Land Policy Branch).
- 5. The selected party may be offered for lease out the low land area for three years with 10% increment of the selected bid price after completion of each year.
- 6. EMD: The participating bidders have to deposit an EMD of Rs. 5,000/- (Rupees five thousand only) along with the quotation through DD/Cheque in favour of "PURBA MEDINIPUR KRISHI VIGYAN KENDRA (REVOLVING FUND)", Payable at Kalyanpur, Nandakumar, PurbaMednipur.
- 7. The offer will be given to the successful bidder with highest rate quoted.
- 8. Payment of bid value will be yearly basis in advanced mode. Bid value should be quoted for  $1^{st}$  year only followed by 10% hike in each subsequent year for the next two years. Entire yearly money should be deposited within fifteen days after completion of each year.
