The tender in sealed cover is hereby invited from bonafide parties to collect **special insect** affected small branches in trees (Mainly from **Shirish trees**) in **Main Campus, BCKV without any farms under BCKV**.

Total no of trees X 18 Nos.

Trees infected by special insect X 14 Nos. out of which 18 Nos. of Shirish Trees.

(Minimum tender Value is Rs. 72,000/-)

Intending parties may see the above mentioned item on any working day within 10.30 a.m. and 5.30 pm after making prior appointment with the concerned farm in charge, Teaching Farm, Mondouri and Security officer, BCKV.

Each party has to abide by the terms and conditions mentioned hereunder and any breach, abrogation of the same will automatically lead to cancellation of tender and forfeiture of "Earnest Money / Security Deposit".

1. The rate to be submitted by the party must be written legibly both in figure and in words on a plain sheet duly signed along with detailed mailing address & Mobile No.

The entire cost of the above items as would be offered by the party and duly accepted by the authority will have to be paid to the concerned Incharge against demand draft/cash, within 7 days from the date of acceptance of the tender.
