1. The rate must be ex-godown and exfarm.

The entire cost of the above items as would be offered by the party and duly accepted by the authority will have to be paid to the concerned In-charge against cash within due days from the date of acceptance of the final work order. Otherwise his "Earnest Money / Security deposit will be forfeited.

5. Maintenance & cleaning of above mentioned trees and field will be done by the party. Otherwise your tender will be cancelled.
6. Pruning and damaging of branches/ trees of the experimental plants would not be done during harvesting.
7. **The Draft must be drawn by the bidder with his own name or name of the proprietor.**
8. **The date of the Draft must be in between issuing date of tender to last date of submission of quotation of said tender, otherwise the quotation would be deemed as cancelled.**
