Before spraying any kind of Agricultural Chemicals in the trees, the selected bidder has to take advice from The Farm In-Charge, Balindi Research Complex, B.C.K.V. as per his/her advice, the selected bidder may start spraying in the trees. The selected bidder has to remain cautious so that there is no damage to the trees/orchards due to non-compliance of such advice and/or terms and conditions of this notice. If there is any damage to the trees/orchards except due to physical condition of the trees and/or natural calamities, the Authority can forfeit refundable security deposit and/or can realize compensation and/or cancel the permission for Collection of fruits, as stated above and/or take an appropriate action.
- 15. The selected bidder has to keep the orchards clean all the time. After collection of fruits in the fruiting season of tender period, the orchards should be cleaned properly before handing over the orchards to the Authority.
