- 5) The supply order in total quantity may be more or less on necessity of the indenter.
- 6) The bidders must deliver the items within 30 days after receiving the supply order from the indenter.
- 7) The items are to be delivered at College of Agriculture, BCKV, Chhatna, Bankura, West Bengal.
- 8) EMD: Vendors are required to pay the requisite amount of Rs.12000 (Rupees twelve thousand) only as EMD draft as specified against their quotation. The requisite draft must be submitted as supporting document during submission of e-tender. Without EMD quotations will not be considered for technical/financial comparison. Draft must be in favour of 'Bidhan Chandra Krishi Viswavidyalaya' payable at Kalyani (IFSC: SBIN001082). Supporting document regarding exemption of EMD must be uploaded, if any.
