The aforesaid vacant seats are to be filled up through counselling / admission, follow the University norms and Govt. rules as follows:

- (i) The candidate who have already taken admission in Master's Degree Programme in the academic session 2018-19, can exercise their option to change their department following the same reserved category and module, if he / she so desires.
- (ii) The general candidates who have obtained 28 (twenty eight) & above and SC/ST candidates who have obtained 22 (twenty two) & above as per marks index in the M.Sc. Entrance Test Merit List, are only eligible for admission in the master's degree programme as per availability of seats.
- (iii) The reserved seats (except PH category) are to be filled up in terms of the provisions laid down in clause No. 6(d) of Notification No. 07-Edn(U)- 89 /13 dated 02/01/2014 of Higher Education Department, Govt. of West Bengal.
The clause 6(d) states that *“seat reserved for the **Schedule Cast** candidates and remaining unfilled even after following the instructions laid down in the previous clauses of the rules may be filled up by the **Schedule Tribe** candidates and **vice-versa**. Likewise, seats reserved for the other Back ward Classes, **Category- A** and remaining unfilled even after following the instructions laid down in the previous clauses of the rules may be filled up by the Other Backward Class, **Category-B** candidates and **vice versa**. If after this exercise, reserved seat shall remain unfilled due to non availability of reserved category candidates, such seat shall be taken up for de-reservation in such manner as prescribed under rules 8 of these rules”*.
- (iv) The reserved and unreserved seats are to be filled up from the **domicile candidates of West Bengal** and as per merit list.
- (v) **The 2nd counselling / admission will be held on 14/09/2018 at 12.00 noon in the Convocation Hall, Administrative Building, BCKV, Mohanpur, Nadia.**
- (vi) Interested candidates may appear to attend the counselling / admission of the said courses.
- (vii) Even after 2nd counselling, if any seats remain vacant, those seat(s) may be filled up following University norms and Govt. rules in this respect.
