Six(6) no. of buses are required for providing transpiration from kalyani/Kanchrapra to Mohanpur and for educational / other trips on holidays/ weekdays for short./long distance as and when required. The complete tender paper along with a Draft of Rs. 5000.00(Rupees five thousand) only as earnest money in favour of BCKV on SBI /UBI to be submitted, except our existing provider whose earnest money has already been deposited in our custody. The hiring of buses shall be on the following terms and conditions:
