Admn/BCKV/CSS/44/L-90 dt.26.04.2017, Sealed rate quotations are hereby invited from the interested resourceful experience caterers for running a **Cafeteria** at the Bidhan Chandra Krishi Viswavidyalaya, Mohanpur, Nadia from 06.00 a.m. to 06.00 p.m. on all working days using kitchen, dining, electricity, supplied water etc. The floor area of **Cafeteria** is 26.30mtr x 84.40 metre. The rental charge should be quoted in per monthly basis. The detail terms and conditions are as follows-

### Terms and conditions:

The Tender shall contain the quoted rate per month for running the **Cafeteria** using the kitchen, dining, electricity, supplied water etc. **along with a Bank Draft of Rs.2,000.00(Rupees two thousand ) only as earnest money in favour of BCKV on SBI, Kalyani/UBI, BCKV Branch.**

The successful bidder shall be permitted to run the **Cafeteria** for a term of 03(three) years on leased basis, by an agreement and it may be extended on satisfactory performance assessed by a committee constitute for that purpose later on. At any time the authority may terminate the contact by giving one month prior notice without given any explanation to vendor. **The leased value/rent to be paid in advance for each month by the successful bidder. The meal/Tiffin to be served to Cafeteria on rate to be fixed after prior approval of the committee concerned.**

1. The proportionate charges on consumption of electricity to run the **Cafeteria** to be borne by the successful bidder in every month.
2. The successful bidder shall provide his/her own man power to maintain the **Cafeteria** and cleanliness of the Kitchen including peace and order.
3. Any internal decoration in the **Cafeteria** if required may be allowed after prior approval of the appropriate authority.
4. **The successful bidder shall have to deposit Rs.25, 000.00 (Rupees twenty five thousand) only as security money on Bank Draft in favour of BCKV on SBI, Kalyani/UBI, BCKV Branch [refundable on expiry of the terms as per agreement].**
5. **The interested bonafide vendors/parties are requested to quote their rates in sealed cover and submit the same to the office of the undersigned on or before 15<sup>th</sup> June, 2017.**
