Teaching Farm, Mondouri

- i) Mango tree - 535 Nos. (Only fruits)
- ii) Jackfruit tree - 06 Nos. (Only fruits)
- iii) Shimul tree - 25 Nos. (Only fruits)
- iv) Bel tree - 05 Nos. (Only fruits)

Intending parties may see the above mentioned mango, Jackfruit, Shimul & Bel fruits in the said farm on any working day within 7.00 a.m. and 12.00 noon after making prior appointment with the above mentioned Farms.


