Tender is hereby invited from bonafide parties for lease out of the ponds & ditch at BSF Canning in BCKV, Mohonpur, under the terms and conditions failing which the tender will be deemed as cancelled and the "Earnest Money/ Security Deposit" will be forfeited.

Phase - 4	Pond - 1 No. (Area .13 Acar ) (approx) Ditch (Area .33 Acar) (approx)

The "Security Deposit/ Earnest Money" for the ponds & ditch is Rs. 2,000/- (Two thousand) only separately each phase. The lease out of period of ponds & ditch 01.04.2020 to 31<sup>st</sup> March 2022.

Intending parties may see the above mentioned ponds & ditch in the said farms on any working day within 07.00 a.m. to 01.00 P.M. after making prior appointment with the Farm Incharge above mentioned Farm.

Each party has to abide by the terms and conditions mentioned hereunder and any breach, abrogation of the same will automatically lead to cancellation of tender and forfeiture of "Earnest Money / Security Deposit".

1. The rate to be submitted by the party must be written legibly both in figure and in words on a plain sheet duly signed along with detailed mailing address & mobile No.
2. The entire cost of the above ponds & ditch as would be offered by the party and duly accepted by the authority will have to be paid to the Incharge above mentioned farm, against demand draft, within 7 days from the date of acceptance of the tender.
3. The envelop should be mentioned by **separate phase of the pond clearly** (like phase -1, phase -2 etc).
4. A photocopy of Identity card with photograph, such as EPIC, Driver license, passport etc must be enclosed with tender.
5. The authority of may take water from the said ponds or may use the water of pond at any time, if need be.
6. Erection of hut and cultivation of vegetable at the embankment of the said water bodies is strictly prohibited.
7. The decision of the authority in any case is final.
8. The Earnest Money has to be deposited either by cash or draft. In case of cash, the whole amount has to be deposited to the Farm Incharge BSF, Canning Farm before the tender closed.

The separate phase of tender must be accompanied with an separate "Earnest Money/Security deposit as mentioned above and it must be paid against demand draft to be drawn in favor of "BIDHAN CHANDRA KRISHI VISWAVIDYALYA", payable at UBI, BCKV, or SBI, KALYANI branch.
