a) Technical Bid shall be made in the form as per **Annexure-A.** The technical bid should not have any financial details. It should accompany earnest money in the form of Bank draft. Bids without EMD would be rejected outright. The technical bid shall be kept in a sealed cover superscripting tender no. and date (Technical Bid - Annual Report 2017-18).

b) Financial Bid shall be made in the form as per **Annexure-B.** The financial bid shall be kept in a sealed cover superscripting tender no. and date (Financial Bid-Annual Report 2017-18).

**2)** Both the sealed covers shall be put in another sealed cover superscripting **tender no. and date** and addressed to "The Registrar, Bidhan Chandra KrishiViswavidyalaya, Mohanpur, Nadia, Pin-741252.

**3)** The sealed covers may be **dropped in** the 'Tender Box' which will be available at second floor, Administrative Block, Bidhan Chandra KrishiViswavidyalaya, Mohanpur, Nadia, Pin-741252 till 5:00 PM by 29.08.2019

**4)** The sealed cover containing technical& financial bids will be **opened on 30.08.2019** at 3:00 PM. Interestedbidders may be present or depute their representative (only one) along with their details oncompany's letter head, at the time of opening of bids.

5) Financial bids of technically suitable bidders will only be opened.

**6)** The firm/printer should have executed **similar printing order** of such scale during the immediatelypreceding three years and must submit all necessary documents in support of such claim.

7) EMD may be forfeited in case the technically lowest bidder has refused to accept the order.

**8)Softcopy** of English report in MS Office format (MS Word/MS Excel/PDF) will be provided to the printer. Printer shall arrange the reformatting of the matter in the printing format.

**9)Proofs:** Successful tenderer should prepare a proof copy for verification purposes within three days of receipt of Work/Supply Order. Three proof readings including page layouts should be provided to the University for finalizing one among them. BCKV reserves the right to change the layout, additions/deletions in the text/photographs before accepting for making final prints of reports.

**10)** Bulk printing should be made only after obtaining **confirmation** from the authorized personnel of BCKV in the approved proof.

**11)** Bulk **delivery** should be made within ten (4) days from the date of final confirmation on theproof. Printer has also to submit the soft copy of the final report in printable/PDF format forinstitute's records purposes and uploading on institute's website.

**12)** The **EMD** of the successful bidder will be refunded only after successful completion of work.

**13)Payment:** 100% payment within 30/45 days from the date of supply and delivery of ordered quantity of Annual Reports at our end in good condition and certification of the concerned authority.

**14)**The University reserves the right to **accept or reject** any bid without assigning any reason thereof.

**15)** All the **copyright** of the annual report will be with BCKV.None of the contents should be revealed to any person not associated with the Report work, normaterial in the report in any form, should be shared by the successful bidder with anybody.
