Tender is hereby invited from bona fide parties for lease out of the ponds at DSF "AB" Block, Kalyani including revocation under the terms and conditions failing which the tender will be deemed as cancelled and the "Earnest Money/ Security Deposit" will be forfeited.

- 1) 1 no. low land at DSF "AB" Block about 5 bighas this land will be renovated to develop pond. Lease out of period from issuing work order to 31.03.2023  
2) 1 no. pond lease out of 01.04.2020 to 31.03.2023  
The "Security Deposit/ Earnest Money" for the tender is Rs. 20,000/- (Twenty thousand) only.

Intending parties may see the above mentioned low land in the said farms on any working day within 7.00 a.m. and 12.00 noons after making prior appointment with the farm ADF above mentioned Farms.

Each party has to abide by the terms and conditions mentioned "Earnest Money / Security Deposit".

1. The ponds & low land of the said farm is to be renovated by the party with their own cost
2. The rate to be submitted by the party must be written legibly both in figure and in words on a plain sheet duly singed along with detailed mailing address & mobile no(if any).
3. The authority may take water from the said ponds at any time , if need be.
4. Erection of hut and cultivation of vegetable at the embankment of the said water bodies is strictly prohibited.
5. The renovated earth from the pond can not be brought out-side of the farm in any case. Selling of earth (inside or outside of the farm) is strictly prohibited. The authority can take any legal action if such allegation is proved the earth will be utilised for bank development(at least 15) farm road development, land development etc, by the party.
6. The decision of the authority in any case is final.
