NOTIFICATION

In continuation of earlier Notification No. BCKV/DP/Grant-3/Pt.XVI/L-431 dated 15.01.2021, issued in respect of implementation of **Academic Management System (AMS)** in the University, this is to further notify as follows –

In terms of the resolution adopted in the 247th meeting of the Executive Council of Bidhan Chandra Krishi Viswavidyalaya, held on 30.07.2020, Academic Management System (AMS) is being implemented in the University under ICAR's NAHEP initiative.

Government of India has launched the National Agricultural Higher Education Project (NAHEP) under ICAR Education Cell with the objective to support participating Agricultural Universities and ICAR in providing more relevant and higher quality education to the students of Agricultural Universities in the ICAR-AU system. The Component-2A under this NAHEP, entitled 'Investment in ICAR leadership for Agricultural Higher Education', is aimed at facilitating adoption of latest ICT tools in the University education system in order to raise the standard of agricultural education. In this collaborative effort, ICAR has permitted BCKV to participate in the programme and accordingly implement Academic Management System (AMS) within the University.

Academic Management System (AMS) will facilitate automation of various academic processes of the University and at the same time will also enhance efficiency of the overall system by saving time and effort involved in manual processes. The data generated by the system will be used for generating reports at the national agriculture portal by aggregating data from various State Agriculture Universities. It is a web-enabled system for management of various academic activities within the University. The system will cater to the needs of different users, like Deans, Heads of Departments, Teachers, Guides, Students, Administrators and other officials associated with such academic processes. Hence, for successful implementation of this Academic Management System (AMS), active, sincere and continuous involvement of all faculty members (both teaching and research), all students, all administrative heads, along with concerned dealing assistants is absolutely essential and also mandatory.

It may be noted that successful implementation of Academic Management System (AMS) will be one of the prerequisites for accreditation of the University.

At present, as part of this AMS, five sub-modules will be implemented, viz. Course Management, Student Management, Faculty Management, Administration Management and E-Learning.

As designed by ICAR, for the purpose of implementing this system in our University, it is necessary to register all teachers, students (UG, PG & PhD) and the concerned personnel of the University in the AMS Portal (https://bckv.auams.in) immediately. In this respect, AMS Master Trainers have already been identified and appointed in each Faculty/College of the University, as per Notification No. BCKV/DP/Grant-3/Pt.XVI/L-431 dated 15.01.2021 (copy enclosed). These AMS Master Trainers will assist all teachers and students in individual departments of their respective Faculty or College to register in the AMS portal created separately for BCKV.

Dr. Amit Baran Sharangi, Professor, Department of Plantation, Spices, Medicinal and Aromatic Crops, Faculty of Horticulture, BCKV has been appointed as the **Nodal Officer** in respect of implementation of AMS in BCKV.

Dr. Manoj Kumar Nanda, Department of Agricultural Meteorology & Physics, Faculty of Agriculture, BCKV, and Nodal Officer, ICAR-Nodal Cell, BCKV will be the **chief resource person** in respect of implementation of AMS in the University.

In this respect, a **Central AMS Committee** has already been constituted by the Hon'ble Vice-Chancellor under the Chairmanship of Dean, Post Graduate Studies, vide Order No. VC/BCKV/66/435 dated 03.08.2020.

All concerned are hereby requested to extend their full cooperation and assistance in respect of successful implementation of AMS in BCKV.
