NOTIFICATION

In pursuance of the G.O. No.2030-Edn./AG/O/3E(U)-1/2017 (Pt.-I), dated 20.05.2021 issued by the Secretary to the Govt. of West Bengal, Agriculture Department, Education Branch, the retirement age in respect of the full-time regular **Teacher and such other regular employees** who are in receipt of the State Government's notified scale of pay and holding a substantive post in Bidhan Chandra Krishi Viswavidyalaya or any Colleges under the Viswavidyalaya, who are in service on 1<sup>st</sup> June, 2021 i.e. scheduled to retire on or after 30<sup>th</sup> June, 2021 be enhanced from sixty-two (62) years to sixty-five (65) years, with immediate effect.

All other rules/ orders/ notifications regulating service terms and conditions of full-time regular Teacher and such other regular employees, including the rules relating to Death-cum-Retirement Benefits and the rules regarding voluntary retirement shall stand modified to the above extent.

Necessary amendments in the BCKV Act shall be made in due course.
