- Valid Medical Certificate from proper authority for physically challenged persons.
- Passport size Photo (4 copies).

➤ **SUBMISSION OF BLOOD ELECTROPHORESIS (THALASSAEMIA) TEST REPORT:**

The candidates are required to submit self attested copy of Blood Electrophoresis (Thalassaemia) test report to the In-Charge, Health Centre, BCKV or contact the Medical Officer, BCKV for blood test for obtaining the Thalassaemia test report on the date of physical verification.

➤ **CANCELLATION OF ADMISSION:**

If any misrepresentation and/or suppression of facts by any candidate gets detected at any stage of physical verification, even at any time during the course of his/her study, his/ her admission would be cancelled.

The decision of the admission Committee will be treated as final.

Mode of ranking as follows:**➤ For General Stream (WBCHSE/Other Boards):**

Step 1 :	The provisional merit list has been prepared based on the marks index generated, taking into consideration the total marks obtained in Physics, Chemistry, Biology and English
Step 2 :	In case of a tie between two or more candidates in Step 1, the total marks obtained in Physics, Chemistry and Biology has been taken into consideration for deciding the ranking of the candidates
Step 3 :	In case of a tie between two or more candidates in Step 2, the marks obtained in Biology has been taken into consideration for deciding the ranking of the candidates
Step 4 :	In case of a tie between two or more candidates in Step 3, the marks obtained in Chemistry has been taken into consideration for deciding the ranking of the candidates
Step 5 :	In case of a tie between two or more candidates in Step 4, the marks obtained in Physics has been taken into consideration for deciding the ranking of the candidates
Step 6 :	In case of a tie between two or more candidates in Step 5, the marks obtained in English has been taken into consideration for deciding the ranking of the candidates
Step 7 :	In case of a tie even after Step 6, the date of birth of the candidates will be the deciding factor in respect of ascertaining the position of a candidate in the ranking list. Candidate who was borne earlier would be placed ahead of the candidate who was borne later

Step 6 :	In case of a tie after Step 5, marks of column (g) have been taken into consideration for deciding the ranking of the candidates
Step 7 :	In case of a tie even after Step 6, the <i>date of birth of the candidates</i> has been considered as deciding factor in respect of ascertaining the position of a candidate in the ranking list. <i>Candidate who was borne earlier would be placed ahead of the candidate who was borne later</i>
