**Sub: Offline counseling and admission (2<sup>nd</sup> Phase) to Doctoral Degree Programme; 2021-22 for the Domicile Candidates of West Bengal.**

In continuation of earlier Notification bearing No. A/UG/Ag-1(Part-VI)/L-594 dated 18/12/2021, it is notified to all concerned that few number of seats are remaining vacant for admission to Ph.D. courses at BCKV for the academic session 2021-22 after 1<sup>st</sup> phase counseling. The list of the vacant seat is being enclosed (Annexure-I).

**The vacant seats will be filled up as per following guidelines:**

- i) Admission will be taken in terms of the Notification No.1, bearing No. A/Ph.D-12(Part-III)/L-355 dated 17/09/2021 and as per provisional list for admission to Doctoral Degree Programme bearing No. A/Ph.D-12(Part-III)/L-541 dated 01/12/2021 (Notification No. 2).
- ii) The vacant seat will be filled up from the domicile candidates of West Bengal and as per availability of seats.
- iii) The URS seat will be filled up from the candidates of domicile of West Bengal.
- iv) In terms of the Notification No. REG/RS-140 dated 01/11/2021, the leftover/vacant seats earmark for In-service candidates will be considered open for the students of the respective Faculties of this University for the year 2021-22 and these seats will be treated as self-finance seats and be regulated as per the students' admission and other rules for self finance students.
- v) The candidates who remained absent in the 1<sup>st</sup> phase counseling, are not eligible for 2<sup>nd</sup> phase counseling/admission.
- vi) **Reservation policy for admission will be followed as per W.B. Govt. norms.**
- vii) Admission will be conducted following COVID-19 protocol.
- viii) If any vacancy arises after publication of this notification, the vacant seat will be filled up on that date i.e. 28/12/2021.

**Candidates failing to attend the counseling as per the above mentioned schedule, will not be allowed to take admission. The decision of the Admission Committee will be final.**

4. Domicile Certificate issued by the Competent Authority (Chairman or Executive Officer of the Municipality/ Commissioner or Administrator of Municipal Corporation/ Pradhan, Gram Panchayat /B.D.O./ S.D.O.
5. AADHAAR CARD of the candidate
6. Two (2) copies of recent colour passport size photograph.
7. Valid Medical Certificate from appropriate authority (Sub-Divisional medical Officer, Superintendent of State Hospital or above category) for PWD Candidates.
8. Applicants having Master degree from other University (Except BCKV) will have to produce a certificate from appropriate authority mentioning that his / her Faculty /College/ Programme in the University is either ICAR-accredited or State Government aided or AICTE approved before taking admission/reporting, failing which the candidature will liable to be cancelled.
