NOTIFICATION

In terms of the resolutions adopted in the 257th meeting of the Executive Council, Bidhan Chandra Krishi Viswavidyalaya (BCKV), held on 16.12.2022, this is to notify that the following directives are to be strictly followed by various educational societies functioning in and outside BCKV, using the name of BCKV –

- (a) The Societies need to submit their functioning proposal under the University umbrella to the Registrar, BCKV, for its approval by the Vice-Chancellor, BCKV and subsequently by the Executive Council, BCKV.
- (b) The important office bearers of these Societies should be permanent teachers/scientists of this University, who are in University service.
- (c) Each such Society must submit their by-laws, which would be thoroughly scrutinized by the University's Legal Cell.
- (d) The Societies need to sign a MoU with the University, in respect of their functioning in BCKV.
- (e) In respect of using University name and logo for any purpose, the Societies should seek permission of the Hon'ble Vice-Chancellor, BCKV on case to case basis.
- (f) In future if any Society is found to flout the stated directives, such unauthorized and unfair activities would be sternly rejected and the society would also be cast aside.

The above rules and regulations shall be applicable with immediate effect.

All previous approval, if any, stands cancelled.
