General Instruction:-

- Admission will be conducted as per Ph.D. Notification No.1/2023-24 dt. 04/09/2023 and Notification No.2/2023-24 dt. 08/09/2023. During counseling, admission will be taken as per rank and availability of seats. For all the seats, reservation policy for admission will be followed as per rules of Govt. of West Bengal.
- The non-allotted/vacant seats of ICAR will be filled up from BCKV Master Degree Pass out students only.
- Candidates who remained absent in 1st and 2nd round of counselling, will not be eligible to appear for counselling.
- Hostel allotment will be done on the date of admission as per availability of seats.
- Candidates failing to attend the counseling as per the above mentioned schedule, will not be allowed to take admission. The decision of the Admission Committee will be final.
- **Venue:** Office of the Dean, P.G. Studies, BCKV, Mohanpur, Nadia, West Bengal, India.
- **Train Route Direction:** Nearest Railway Station: Kanchrapara (Eastern Railway). From station by bus (Route No. 22- Kanchrapara to Nagarukhra)/ Auto. **Stoppage-** Mohanpur, **BCKV Main Gate.**

➤ **Candidates are hereby directed to produce the following documents (SELF ATTESTED PHOTOCOPIES IN A-4 SIZE PAPER) & ORIGINAL at the time of counseling and admission for necessary verification:**

- (i) Downloaded online application form
- (ii) Mark-sheets/Grade Cards of Examination: Bachelor's Degree (4-Years Degree Course) [Both Side], Master's Degree (2 years) [Both side]
- (iii) Age-proof certificate [Birth Certificate/ Admit Card or Certificate of Secondary Examination (10th Standard)].
- (iv) SC/ST/PwD/OBC-A/OBC-B certificates from the competent authority (for reserved seat).
- (v) Domicile Certificate issued by competent authority (S.D.O/D.M.).
- (vi) AADHAAR card of the candidate.
- (vii) Two (2) copies of recent colour passport size photograph.
- (viii) Self-attested copy of valid medical certificate from appropriate authority (Sub-Divisional Medical Officer, Superintendent of State Hospital or above category) for person with disability (PwD) candidates.

➤ **Accreditation Certificate:**

For M.Sc. (Agriculture/Horticulture): Applicants having bachelor degree from other University or college will have to produce a certificate from appropriate authority mentioning that his/her Faculty/College is either ICAR-accredited or is aided by State Government before taking admission/ reporting, failing which his/her candidature is liable to be cancelled.

For M.Tech. Agril. Engineering: Applicants having Bachelor Degree from other University or college will have to produce a certificate from appropriate authority mentioning that his/her Faculty/ college/ Programme is either AICTE approved or is aided by State Government, before taking admission/ reporting failing which his/her candidature is liable to be cancelled.

➤ **SUBMISSION OF BLOOD ELECTROPHORESIS (THALASSAEMIA) TEST REPORT:**

Only after receipt of Anti-Ragging Declaration, the University Registration Certificate would be issued to the admitted candidates.
