- 1) Admission will be conducted as per rank, availability of seats and other terms & conditions as stipulated in the U.G. Notification No. 1/2024-25 [Ref. No. Admission/UG/Ag-1(Part-IX)/L-124 dt. 06/06/2024].
- 2) Candidates failing to attend as per above mentioned schedule, will not be allowed to take admission. The decision of the Admission Committee will be final.
- 3) Venue: Convocation Hall, Administrative Building, BCKV, Mohanpur, Nadia, West Bengal, India.

4) Route Direction:

- i) **Train Route Direction:** Nearest Railway Station: - Kanchrapara (Eastern Railway). From station by bus (Route No. 22- Kanchrapara to Nagarukhra)/ Auto. **Stoppage-** Mohanpur, BCKV Main Gate.
- ii) **Bus Route Direction:** 12 National Highway (Siliguri to Kolkata / Kolkata to Siliguri bus route) by bus, **Stoppage - Barajaguli.** From Barajaguli by Auto/ Toto/ Van Rickshaw /Bus to Mohanpur, BCKV Main Gate (Approx 5 minutes)

5) Candidates are hereby directed to produce the following documents in original and photocopies in A-4 size paper (as per uploaded copy) at the time of Counseling /Admission for necessary verification:

- i) Printed copy of online Application Form and money receipt.
- ii) Self attested photocopy of H.S. Mark-sheet (both side) & Age-proof certificate (Birth certificate/Certificate of Secondary Examination).
- iii) Self attested photocopy of valid medical certificate from proper authority for physically challenged persons.
- iv) Self attested photocopy of certificate of the competent authority (Category – SC/ST/OBC-A/OBC-B).
- v) Self attested photocopy of the Domicile Certificate issued by the concerned District Magistrate (D.M.) or Sub- Divisional Officer (S.D.O).
- vi) Self attested photocopy of AADHAAR CARD and Bank Account details must have to be submitted as per ICAR Rules for USID generation.
- vii) **School Leaving Certificate/ Transfer Certificate/ Migration Certificate/ Character Certificate issued by the school or institution last attend by the candidate.**

7) Submission of Blood Electrophoresis (Thalassaemia) Test Report:

The candidates who will be admitted after counselling are required to submit self attested copy of Blood Electrophoresis (Thalassaemia) test report to the concerned Medical Officer, BCKV Health Centre within one month from the date of starting of class.

- 8) **Reservation of seats** will be followed as per the rule of Govt. of West Bengal. Admission would be made as per option exercised by the candidates. The option once exercised shall be treated as final.

9) Anti-Ragging Regulation (as per UGC Regulation):

- i) Ragging is totally prohibited in the Institution. Any student found guilty of ragging and/or abetting ragging whether actively or passively, or being a part of a conspiracy to promote ragging is liable to be punished in accordance with UGC regulation Clause No. 6.1a as well as under the provision of any panel law for the time being in force.
- ii) UGC regulations in respect of curbing ragging in Higher Educational Institution, 2009 [Ref. No. F/1-16/2009(CPP-II) September, 2009] is enclosed.

iii) Telephone of the anti ragging help line:

- v) **The students and parent/ guardian must also submit additional affidavit (Annexure I and II) to the DSW within one month from date of admission.**
