Sub: Publication of provisional merit list for admission to Master Degree Programme for the session: 2024-25

In continuation of our earlier notification vide no. A/PG/AG-9(Part-IX)/L-272, dated 30/08/2024 (PG Notification No.1/2024-25), it is notified to all concerned that the Provisional Merit List for admission to Master's Degree Programme 2024-25 is being published on the University website. The provisional merit list has been prepared based on the data as provided by the candidate himself/herself and marks obtained by candidates in the entrance examination.

The following procedure has been followed for preparation of merit list.

Step 1:	The provisional merit list of the candidates has been prepared based on the marks index prepared taking into consideration 10% of H.S. score + 20% of B.Sc./B.Tech. score + marks obtained in the
	entrance examination + 10% of B.Sc./B.Tech. Score for BCKV Pass out students.
Step 2:	In case of a tie between two or more candidates in Step 1, the marks obtained in entrance
	examination has been taken into consideration for deciding the ranking of the candidates.
Step 3:	In case of a tie between two or more candidates in Step 2, the score in B.Sc./B.Tech has been
	taken into consideration for deciding the ranking of the candidates.
Step 4:	In case of a tie between two or more candidates in Step 3, the score in Higher Secondary has been
	taken into consideration for deciding the ranking of the candidates.
Step 5:	In case of a tie between two or more candidates in Step 4, the date of birth of the candidates is the
	deciding factor in respect of ascertaining the position of a candidate in the ranking list. Candidate
	who was born earlier is placed ahead of the candidate who was born later.

If it is found at any stage that a candidate has secured his/her position in the merit list by misrepresentation and/or suppression of facts, his/her admission shall stand cancelled.
