

Sub: Re E-Tender Notice regarding leasing out of the Natural Ventilated Polyhouses under AICRP on Floriculture at Mondouri, BCKV for a period of one year from the date of issuance of the final work order

Expression of Interest (EOI) for Leasing Out Natural Ventilated Poly-houses under AICRP on Floriculture at Mondouri, BCKV, the authority is inviting "Expression of Interests (EOI)" from eligible parties (Person/Company) to lease out three (3) polyhouses for sustainable maintenance.

- 1. The applicant has to apply in <wbtenders.gov.in> portal.
- 2. At the time of applying online in <wbtenders.gov.in> portal, the applicant has to download the specified Application format and after filling up the format completely, the same has to be scanned and scanned copy should be uploaded in the "Application folder' (in.pdf format).
- 3. The applicant has to upload scanned copy of self attested photocopy of his/her Aadhaar Card in the 'Adhar Card' folder while applying online (in.pdf format).
- 4. The applicant has to upload scanned copy of self attested photocopy of his/her PAN Card in the 'PAN Card' folder while applying online (in.pdf format).
- 5. The applicant must upload dully filled in specified Application format. Aadhaar Card and PAN Card in the above stated manner, otherwise his/her offer will be rejected straightway. The applicant must retain hard copies of the uploaded documents because those may be required to be submitted in later stage.
- 6. The applicant quoting highest amount for one polyhouse (per year) will be selected (Format given in Table-1.Selected party (from EOI) shall be liable for maintenance of the Polyhouses and ensuring its full utility by producing flowers initially for one (1) year only. After being selected, the party shall deposit full amount quoted per polyhouse in advance at the University account. After depositing the quoted amount for three polyhouses (for one year) the party will sign a contract agreement (MOU) for 1 (one) year only, with the University Authority (BCKV).

- 7. The applicant has to be bid above the minimum price fixed for this purpose which is Rs. 1,00,000.00 (Rupees one lakh only) per polyhouse per year. Any bid below the minimum price will not be considered.
- 8. The applicant should be **maintained the infrastructure** for production of flowers for **collaborative research**, production of other value added products and subsequent market linkage. Utilization of waste flowers to make some useful products through processing and value addition and **strengthen University's efforts** through sustainability of present infrastructure (Polyhouses).
- 9. After successful completion of one year, the Agreement may be extended upon consent of both the parties. The selected party has to keep the polyhouses clean all the time. Before spraying any kind of Agricultural Chemicals in the flowers, the selected party has to take advice from the Officer In-Charge, AICRP on Floriculture. The selected party has to maintain close contact with The Officer In-Charge, AICRP on Floriculture. No farm equipments / implements will be provided to the selected party.
- 10. The selected party or his/her nominated/ authorized persons shall not indulge in any activity which is detrimental to the interests of the research experiment and / or Farm in general, otherwise the entire responsibility shall lie on the selected party and in that case authority can take appropriate action and/or appropriate legal action which the authority may deem fit.
- 11. The University authority shall not be held responsible for any kind of losses/damages due to pilferage/ theft of flowers/ natural calamities etc. With the permission of the Authority, the selected party may make necessary arrangement for protection of flowers at his/her own risk and responsibilities.
- 12. The University reserves the right to reject or accept any EOI without assigning any reason what so ever.
- 13. Interested persons/parties can inspect the natural ventilated polyhouse at Mondouri AICRP on Floriculture, on any working day of the Viswavidyalaya between 7:30 a.m. to 12:00 noon with the prior permission of the Officer In-charge, AICRP on Floriculture.

Special Terms and conditions:

- The parties may please submit scanned copy of self attested photocopy of trade license and IT Return (last year) along with the Quotation.
- The selected party has to deposit the amount of Rupees (To be quoted by him per year/polyhouse) for three polyhouses per year at a time, which will be non-refundable.
 - <u>Time:</u> For one year from signing the MOU, which may be may be extended upon consent of both the parties
