

1. The applicant has to apply **online** in **<wbenders.gov.in>** portal.
2. At the time of applying online in **<wbenders.gov.in>** portal, the applicant has to download the specified Application format and after filling up the format completely, the same has to be scanned and scanned copy should be uploaded in the **“Application folder”** (in .pdf format).
3. The Applicant has to upload scanned copy of self attested photocopy of his/her Aadhar Card in the **“Aadhar Card”** folder while applying online (in .pdf format).
4. The applicant has to upload scanned copy of self attested photocopy of his/her PAN Card in the **“PAN Card”** folder while applying online (in .pdf format).
5. The applicant must upload duly filled in Application specified format, Aadhar Card and PAN Card in the above stated manner, otherwise his/her offer will be rejected straightway and his/her EMD will be forfeited without any further reference to him/her. The applicants must retain hard copies of the uploaded documents because those may be required to be submitted in later stage.



6. The applicant **has to bid above the minimum price fixed for this purpose** which is **Rs. 8,40,000/- (Rupees Eight lakhs forty thousand only)**. Any bid below the minimum price will not be considered and in that case, the EMD will be forfeited and/or the Authority can take appropriate action.
7. An amount of **Rs. 21,000/- (Rupees Twenty one thousand only)** should be deposited as EMD at the time of applying online.
8. **EMD should be deposited through <wbtenders.gov.in> portal.**
9. The selected bidder has to deposit **Rs. 84,000/- (Rupees Eighty four thousand only) as Refundable Security Deposit**. The EMD amount Rs. 21,000/- (Rupees Twenty one thousand only) will be converted as part of Refundable Security Deposit. Balance amount of Refundable Security Deposit i.e. (Rs. 84,000/- - Rs. 21,000/-) **Rs. 63,000/- (Rupees Sixty three thousand only)** has to be deposited by the selected bidder in the form of A/C Payee Demand Draft drawn on any Nationalized Bank in favour of "**Bidhan Chandra Krishi Viswavidyalaya**", payable at SBI, Kalyani Branch (IFSC-SBIN0001082) or at PNB, BCKVV Brach (IFSC-PUNB0075920).  
The selected bidder should deposit his/her **entire bidded amount** in the form of A/C Payee Demand Draft drawn on any Nationalized Bank in favour of "**Bidhan Chandra Krishi Viswavidyalaya**", payable at SBI, Kalyani Branch (IFSC-SBIN0001082) or at PNB, BCKVV Brach (IFSC-PUNB0075920).  
The above said two Demand Drafts (one for balance security deposit and another for his/her bidded amount) have to be deposited **simultaneously** within the time period which will be intimated to him/her through formal communication. Failure to do so, will lead to cancellation of the offer and forfeiture of EMD without any further reference to him/her.
10. Immediately after completion of harvest of Litchi fruits in the fruiting season of the year 2026, the selected bidder has to hand over the litchi orchards to the authority, otherwise his /her refundable security deposit will be forfeited and/or authority can take appropriate action.
11. After handing over litchi orchards to the Authority, Refundable Security Deposit will be released on the basis of satisfactory performance certificate from the Farm In-charge, Mondouri Horticulture Farm in favour of the selected bidder. For this purpose the selected bidder has to make an application enclosing photocopy of the first page of his/her own Bank Passbook and photocopy of his/her Aadhar card. No interest will be payable at the time of releasing Refundable security Deposit.
12. The Authority does not give any kind of guarantee whatsoever regarding the production of fruits in the orchards.

13. The authority shall not be held responsible for any kind of damage/ pilferage/ theft of fruits/trees. With the permission of the Authority, the selected bidder may make necessary arrangement for protection of fruits /trees at his/her own risk and responsibility.

The authority shall not be held responsible for any kind of damage to the trees, due to physical condition of the trees and/or natural calamities, if any.

14. Before spraying any kind of Agricultural Chemicals in the trees, the selected bidder has to take advice from the Head, Dept. of Fruit Science, F/Horticulture and as per his/her advice, the selected bidder may start spraying in the trees. The selected bidder has to remain cautious so that there is no damage to the trees/orchards due to non-compliance of such advice and/or terms and conditions of this notice. If there is any damage to the trees/orchards except due to physical condition of the trees and/or natural calamities, the Authority can forfeit refundable security deposit and/or can realize compensation and/or cancel the permission for collection of fruits, as stated above and/or take an appropriate action.

15. The selected bidder has to keep the orchards clean all the time. After collection of fruits in the fruiting season of the year 2026, the orchards should be cleaned properly before handing over the orchards to the Authority.

16. Authority reserves the right to add/delete/change/alter/modify terms and conditions of this tender notice at any time without assigning any reason whatsoever.

17. Authority reserves the right to cancel any part or whole of this tender without assigning any reason thereof.

18. Bidding the highest rate does not automatically entitle an applicant to get the permission for collection of fruits, as stated above.

19. During the life of this tender notice, all concerned are hereby advised to visit regularly university website <[www.bckv.edu.in](http://www.bckv.edu.in)> and <[wbtenders.gov.in](http://wbtenders.gov.in)> portal for corrigendum in respect of this tender notice, if any.

20. If any dispute arises, decision of the Authority will be final and binding upon all concerned.

21. The Authority is not liable to accept the highest bid and reserves the right to reject any offer/all offers without assigning any reason whatsoever.

22. Interested persons can inspect the litchi orchards at Mondouri Horticultural Farm on any working day of the Viswavidyalaya between 7:30 a.m. to 12:00 noon with the prior permission of the Farm In-charge, Mondouri Horticultural Farm.


23. No farm equipments / implements will be provided to the selected bidder.

24. The selected bidder has to maintain close contact with the Farm In-charge, Mondouri Horticultural Farm during the entire period.

25. The trees will be utilized for Research purposes. The selected bidder will not harvest fruits which earmarked for research purposes without making consultations with the concerned scientists/P.G. students and after getting their consent, the selected bidder will harvest those fruits.

At the time of harvesting of fruits, absolute care should be taken by the selected bidder so that there is no damage to the branches of the trees/properties of the farm.

26. The bidder will have to supply, 800 litchi fruits from 40 plants of Bombai litchi variety (20 fruits/plant) and 280 fruits from remaining 14 varieties (20 fruits/variety) free of cost for research purpose of students and scientists.

27. 15 Nos. of ripe fruits per tree will be collected free of cost from 236 Nos. of Litchi trees under AICRP on fruits by the scientist of the concerned project for experimental purposes.

28. The selected bidder or his/her nominated/ authorized persons shall not indulge in any activity which is detrimental to the interests of the research experiment and / or Farm in general, otherwise the entire responsibility shall lie on the selected bidder and in that case authority can take appropriate action which may lead to forfeiture of Refundable security deposit and/or cancellation of the permission for collection of fruits, as stated above and/or appropriate legal action and/or any other action which the authority may deem fit.
