❖ **Candidates are hereby directed to produce the following documents in ORIGINAL along with SELF ATTESTED PHOTOCOPIES OF THE SAME IN A-4 SIZE PAPER at the time of physical reporting:**

1. Documents uploaded at the time of online application and counselling.
2. Copy of Payment Receipt of Registration Fee paid to ICAR.
3. Computer generated confirmation page of on-line application submitted to NTA.
4. Rank Card issued by the ICAR to eligible candidates.
5. Provisional admission letter issued by ICAR.
6. Allotment Letter Issued by the ICAR to eligible candidate.
7. Passport size colour photographs same as uploaded at the time of on-line application to NTA (4 copies).
8. Bank Account details must have to be submitted as per ICAR rules for USID generation.

❖ Following **Admission Fees** (including 1st semester fees) are to be paid by the admitted candidates on the date of physical reporting itself, either in cash or in online mode. In online mode, fees will be collected either through Debit Card or Credit Card or UPI or Net Banking. However, admission will be made subject to the condition of actual realization of admission fee in the dedicated University bank account –

➤ **SUBMISSION OF BLOOD ELECTROPHORESIS (THALASSAEMIA) TEST REPORT:**

The candidates are required to submit self attested copy of Blood Electrophoresis (Thalassaemia) test report to the In-Charge, Health Centre, BCKV.

➤ **ANTI-RAGGING:** Anti-ragging declaration in the form of affidavit (as per prescribed format to be provided at the time of admission) duly signed by the admitted candidates and their guardians is to be submitted to the Office of Dean, Students' Welfare after starting of classes. Only after receipt of Anti-Ragging Declaration, the University Registration Certificate would be issued to the admitted candidates.

➤ **CANCELLATION OF ADMISSION:**

If any misrepresentation and/or suppression of facts by any candidate are found at any stage of physical verification, even at any time during the course of study, his/ her admission shall be cancelled.
