The Principal Investigator project "Use of Jute Agro Textiles as prospective mulching material to test the suitability of mango based intercropping systems towards increasing crop productivity and promotion of livelihood security for the backward farming community of Red and Lateritic Zones of West Bengal" NTTM, GOI, College of Agriculture, Susunia, Chhatna, Bankura (Extended campus of BCKV) is invited Sealed quotations from the bona fide suppliers/ nursery for supplying the seedling as per specifications stated below within **Fifteen (15) days of publication.**

4	Foot Yam Rhizome	Mature rhizome, average one Kg. weight	8080 kg

#### **Terms & Conditions:**

1. EMD of Rs. 10000/- (Rupees ten thousand) only as specified along with their quotations is to be uploaded through Demand draft in favour of 'Bidhan Chandra Krishi Viswavidyalaya, payable at Kalyani (IFSC: SBIN0001082) along with the quotation. Without EMD quotation will not be considered for financial comparison. EMD exemption certificate must be submitted with the quotation documents, if any.
2. The bidders should have I.T Return (last three years), current trade license, GST related certificates and PAN etc. In case of GST exemption, supporting documents should be provided.
3. The bidders should have experience in mango, papaya, and foot yam sapling/planting materials trading, involving the farmers, which will be supported by work orders and completion certificates.
4. Nursery visits by appropriate authorities are mandatory before opening the financial bid.
5. The lowest price/bid of all items in total is to be considered.
6. Sapling and rhizome must be delivered to the project field at Chhatna (Bankura) and Jalda I (Purulia District).
7. Quantity may be changed up to 10% according to availability of fund
8. Upon supply of any inferior material, it will be rejected and deducted from the payable amount, and in extreme cases, the work order may be cancelled. The buyer will not be responsible for deduction in payment/cancellation of the purchase order due to quality and quantity issues. The quoted price should be inclusive of all taxes, if any. The rates should be quoted on a per-number basis, including all taxes, which should be mentioned clearly.
9. The quoted price must be valid for at least 120 days from the opening of the financial bid.
10. The purchase order will be issued subject to the availability of funds for the respective head.
