Intending parties may see the above mentioned Bidhan Khesari in the said farms on any working day within 7.00 a.m. and 12.00 noon after making prior appointment with the concerned farm Incharge.

The entire cost of the above paddy as would be offered by the party and duly accepted by the authority will have to be paid to the concerned Incharge against demand draft or cash, within 7 days from the date of acceptance of the tender.
