Step 1	The provisional merit list has been prepared based on the marks index generated, taking into consideration the total marks obtained in Physics, Chemistry, Biology and English		
Step 2	 In case of a tie between two or more candidates in Step 1, the total marks obtained in Physics, Chemistry and Biology has been taken into consideration for deciding the ranking of the candidates 		
Step 3	In case of a tie between two or more candidates in Step 2, the marks obtained in Biology has been taken into consideration for deciding the ranking of the candidates		
Step 4	In case of a tie between two or more candidates in Step 3, the marks obtained in Chemistry has been taken into consideration for deciding the ranking of the candidates		
Step 5	In case of a tie between two or more candidates in Step 4, the marks obtained in Physics has been taken into consideration for deciding the ranking of the candidates		
Step 6	In case of a tie between two or more candidates in Step 5, the marks obtained in English has been taken into consideration for deciding the ranking of the candidates		
Step 7	In case of a tie even after Step 6, the date of birth of the candidates will be the deciding factor in respect of ascertaining the position of a candidate in the ranking list. Candidate who was born earlier would be placed ahead of the candidate who was born later

F)Important instructions for candidates:

- Candidates are hereby directed to produce the following documents in original and self attested photocopies in A-4 size paper (as per uploaded copy) at the time of Counseling /Admission for necessary verification:
- 1. Printed 2 copies of online Application Form and money receipt.
- 2. Age-proof certificate (Birth certificate/Certificate of Secondary Examination).
- 3. Photocopy of APPAR/ ABC ID.
- 4. Candidates will be required to submit of Domicile Certificate issued by the concerned District Magistrate (DM) or Sub Divisional Officer (SDO) at the time of admission.
- 5. Photocopy of H.S. Mark-sheet (both side).
- 6. Photocopy of applicant's AADHAAR Card.
- 7. School Leaving Certificate/ Transfer Certificate/ Migration Certificate/ Character Certificate issued by the school or institution last attend by the candidate.
- 8. Bank Account details must have to be submitted as per ICAR Rules for USID generation.
- 9. Recent 4 copies passport size colour photograph with 80% face (without mask) visible including ears against a **white background.**
- 10. Photocopy of Parents' Aadhaar Card (Father and Mother).
- 11. Valid reservation certificate of the competent authority (Category SC/ ST).
- 12. Valid EWS certificate for EWS candidate should be issued by DM/ ADM/ SDO/ DWO.
- 13. Valid medical certificate from proper authority for physically challenged (PwD) persons.

G) Important information for candidates:

- 1) Admission will be conducted as per rank, availability of seats and other terms & conditions as stipulated in the "BCKV Admission Brochure, Under Graduate Degree Programme- 2025".
- 2) Candidates failing to attend as per above mentioned schedule, will not be allowed to take admission. The decision of the Admission Committee will be final.
- 3) The marks mentioned by the candidates in the application form does not match with the marks mentioned in the original mark sheets, then it will be considered as wrong information and **the candidature of the applicant will be summarily rejected**. This will be applicable in both cases (a) if the applicant has put higher marks than the original marks or (b) if the applicant has put lower marks than the original marks.
- 4) In respect of candidates, whose Higher Secondary Mark Sheet has been subsequently reviewed and revised after 26.06.2025 by the concerned Board, those cases would be considered. Based on the revised marks if the merit ranking of an applicant gets upgraded, he/she would be considered for admission as per his/her original position in the Provisional Merit List prepared based on the information provided by the candidate in the online application form as on 26.06.2025. However, based on the revised marks if the merit ranking of an applicant gets downgraded, he/she would not be considered for admission.
- 5) Venue: Convocation Hall, Administrative Building, BCKV, Mohanpur, Nadia, West Bengal, India.
- 6) Jurisdiction for all disputes shall be Kalyani.
