Sub: Re-E-tender Notice regarding lease out for collection of Mango and Litchi fruits from the Mango and Litchi Orchards in C.R. Farm, Gayeshpur, Bidhan Chandra Krishi Viswavidyalaya for 02 (Two) fruiting seasons from the date of issuance final work order.

- The applicant has to apply online in <wbttenders.gov.in> portal.
 - At the time of applying online in <wbttenders.gov.in> portal, the applicant has to download the specified Application format and after filling up the format completely, the same has to be scanned and scanned copy should be uploaded in the "Application folder" (in .pdf format).
 - The Applicant has to upload scanned copy of self attested photocopy of his/her Aadhaar Card in the "Aadhaar Card" folder while applying online (in .pdf format).
 - The Applicant has to upload scanned copy of self attested photocopy of his/her PAN Card in the "PAN Card" folder while applying online (in .pdf format).
 - The applicant must upload duly filled in specified Application format, Aadhaar Card and PAN Card in the above stated manner, otherwise his/her offer will be rejected straightway and his/her EMD will be forfeited without any further reference to his/her The applicants must retain hard copies of the uploaded documents because those may be required to be submitted in later stage.
 - The applicant has to bid above the minimum price fixed for this purpose which is Rs. 8,22,000/- (Rupees Eight thousand twenty two thousand only). Any bid below the minimum price will not be considered and in that case, the EMD will be forfeited and/or the Authority can take appropriate action.
 - An amount of Rs. 20,550/- (Rupees Twenty thousand five hundred fifty only) has to be deposited by the bidder in the form of A/C Payee Demand Draft drawn on any Nationalized Bank in favour of "Bidhan Chandra Krishi Viswavidyalaya" payable at SBI, Kalyani Branch (IFSC-SBIN0001082) or at PNB, BCKVV Branch (IFSC- PUNB0075920) through <wbttenders.gov.in> at the time of applying online (upload a photocopy of Demand Draft) and the Original draft should be deposited / reached to The Director of Farm office within 05 (Five) days from the last date of tender notice.

9. EMD should be deposited through <wbttenders.gov.in>.
10. The selected bidder has to deposit **Rs. 82,200/- (Rupees Eighty two thousand two hundred only) as Refundable Security Deposit**. The EMD amount of **Rs. 20,550/- (Rupees Twenty thousand five hundred fifty only)** will be converted as part of Refundable Security deposit. Balance amount of Refundable security deposit i.e. (Rs. 82,200/- - 20,550/-) = **Rs. 61,650/- (Rupees Sixty one thousand six hundred fifty only)** has to be deposited by the selected bidder in the form of A/C Payee **Demand Draft** drawn on any Nationalized Bank in favour of "**Bidhan Chandra Krishi Viswavidyalaya**" payable at SBI, Kalyani Branch (IFSC-SBIN0001082) or at PNB, BCKVV Branch (IFSC- PUNB0075920).

The selected bidder should deposit his/her **entire bidded amount** in the form of A/C Payee Demand Draft drawn on any Nationalized Bank in favour of "**Bidhan Chandra Krishi Viswavidyalaya** payable at SBI, Kalyani Branch (IFSC-SBIN0001082) or at PNB, BCKVV Branch (IFSC-PUNB0075920) or cash to the Farm In-Charge, C.R. Farm, Gayeshpur.

The selected bidder have to be deposited the **entire bidded amount** along with one (01) **Demand Draft (Balance security deposit i.e. Rs. 61,650/-)** to the Farm In-Charge, C.R. Farm, Gayeshpur within the time period which will be intimated to his/her through formal communication. Failure to do so, will lead to cancellation of the offer and forfeiture of EMD without any further reference to his/her.

10. Immediately after completion of harvest of Mango and Litchi fruits in the fruiting season of tender period, the selected bidder has to hand over the Mango and Litchi orchards to the authority, otherwise his/her refundable security deposit will be forfeited and/or authority can take appropriate action.
11. After handing over Mango and Litchi orchards to the Authority, Refundable Security Deposit will be released on the basis of satisfactory performance certificate from the Farm In-Charge, C.R. Farm, Gayeshpur, B.C.K.V. in favour of the selected bidder. For this purpose the selected bidder has to make an application enclosing photocopy of the first page of his/her own **Bank Passbook** and photocopy of his/her **Aadhaar card**. No interest will be payable at the time of releasing Refundable security Deposit.
12. The Authority does not give any kind of guarantee whatsoever regarding the production of fruits in the orchards.
13. The authority shall not be held responsible for any kind of damage/ pilferage/ theft of fruits/trees. With the permission of the Authority, the selected bidder may make necessary arrangement for protection of fruits /trees at his/her own risk and responsibility. The authority shall not be held responsible for any kind of damage to the trees, due to physical condition of the trees and/or natural calamities, if any.
14. Before spraying any kind of Agricultural Chemicals in the trees, the selected bidder has to take advice from The Farm In-Charge, C.R. Farm, Gayeshpur, B.C.K.V. as per his/her advice, the selected bidder may start spraying in the trees. The selected bidder has to remain cautious so that there is no damage to the trees/orchards due to non-compliance of such advice and/or terms and conditions of this notice. If there is any damage to the trees/orchards except due to physical condition of the trees and/or natural calamities, the Authority can forfeit refundable security deposit and/or can realize compensation and/or cancel the permission for Collection of fruits, as stated above and/or take an appropriate action.
15. The selected bidder has to keep the orchards clean all the time. After collection of fruits

- in the fruiting season of tender period, the orchards should be cleaned properly before handing over the orchards to the Authority.

Farm, Gayeshpur, B.C.K.V. on any working day of the Viswavidyalaya between 7:30 a.m. to 12:00 noon with the prior permission of the Farm In-Charge, C.R. Farm, Gayeshpur, B.C.K.V. No farm equipments / implements will be provided to the selected bidder.
 23. The selected bidder has to maintain close contact with the Farm In-Charge, C.R. Farm, Gayeshpur, B.C.K.V. during the entire period.
 24. At the time of harvesting of fruits, absolute care should be taken by the selected bidder so that there is no damage to the branches of the trees/properties of the farm.
 25. The selected bidder or his/her nominated/ authorized persons shall not indulge in any activity which is detrimental to the interests of the research experiment and /or Farm in general, otherwise the entire responsibility shall lie on the selected bidder and in that case authority can take appropriate action which may lead to forfeiture of Refundable security deposit and/or cancellation of the permission for collection of fruits, as stated above and/or appropriate legal action and/or any other action which the authority may deem fit.
