The rate to be offered by intending parties must be ex-field and mentioning in figure in words on a plain sheet of paper with detailed mailing address mobile no duly signed. Precaution should be taken so that no damage to other trees and clear the road for general and vehicular thoroughfare.

1. The intending parties may see the trees as above mentioned on any working day between 8.00 a.m. to 2-00 p.m. under supervision of In-Charge, C.R. Farm, Gayeshpur & Security Officer, BCKV and for that purpose the office of the under signed may be contacted.

The tender must be accompanied with an Earnest Money / Security Deposit of Rs 1200/- (One Thousands Two hundred) only must be deposited by bank draft to be drawn in favor of BIDHAN CHANDRA KRISHI VISWAVIDYALAYA payable at PNB, BCKVV or SBI Kalyani or by cash deposited to the cash section of Comptroller, BCKV.

7. The cutting and carrying process of those said trunks from Main Campus, must be under supervision of Security officer, BCKV & Farm In-Charge, Teaching Farm, Mondouri only in Office time and Office working day otherwise the Earnest Money will be forfeited.
8. A photocopy of Identity card with photograph, such as Aadhaar, EPIC, Driving license, passport or PAN Card etc must be enclosed with tender.
9. The Draft must be drawn by the bidder with his own name or name of the proprietor.


