GENERAL CLAUSES

Eligibility Criteria for Participation in the Bidding

- 1) Contractors who have been delisted or debarred by any Government Department shall not be eligible to participate.
- 2) The NIT may be obtained from the Departmental Website. Schedule of works may be obtained from the office of the undersigned on any working day between 11:30 A.M. and 4:00 P.M. before the date mentioned.
- 3) Intending bidders shall submit self-attested photocopies of:
 - Application for permission of tender paper.
 - Trade License
 - PAN Card / Voter ID Card / Aadhaar Card
 - Up-to-date Professional Tax Deposit Challan (2026-27)
 - GST Registration Certificate/Provisional Certificate
 - Latest Income Tax Return (2025-26)
- 4) Permission for participation will be granted after scrutiny of the submitted documents. The bidder must produce original documents whenever demanded by the Tender Inviting Authority. Failure to do so shall lead to rejection of the bid at any stage, even after award of work.
- 5) The work shall be treated as a Measured Work. Quantities may be increased, reduced, or certain items may not be executed as per direction of the Engineer-in-Charge. Payment shall be made on actual quantities executed. No claim shall be entertained for reduction or non-execution of items.
- 6) No mobilization advance or secured advance shall be allowed.
- 7) Bids shall remain valid for 120 (One Hundred Twenty) days from the last date of submission. If a bidder withdraws the bid during the validity period, the earnest money deposited shall be forfeited without assigning any reason.
- 8) The agency shall maintain the completed work at the required service level during the maintenance period as per departmental norms. Any defect or damage found during this period shall be rectified by the contractor at his own cost. Failure to do so may attract penal action.


- 9) The contractor shall remove all unserviceable materials generated during execution to locations as directed by the Engineer-in-Charge. The work site shall be cleaned and dressed after completion. No extra payment shall be made on this account.
- 10) All bidders are requested to remain present in the office of the In-Charge, Works department during opening of the bids.
- 11) The In-Charge, Works department reserves the right to call for Open Bid, Sealed Bid, or Second Call after opening of bids to obtain a suitable rate, if required. No objection in this regard shall be entertained.
- 12) Defect Liability Period as per Government Order vide Memo No. 5784-PW/L&A/2M-175/2017 Dated: 12.09.2017 in this regard as applicable.
- 13) If the successful tenderer fails to commence the work within 7 (seven) days from the date of receipt of work order without showing any valid reason, the work order will be treated as cancelled and his earnest money will be forfeited.
- 14) Labour Welfare Cess @ 1% and Security money @ 10% of the Gross Bill Value shall be deducted from every bill. The Cess & Security money is deemed to be included in the quoted rates.
- 15) **Earnest Money**
 - All bidders shall mandatorily deposit Earnest Money @ 2.5% of the gross quoted amount in the form of Demand Draft/Pay Order from any Nationalized Bank or RBI-listed Bank drawn in favour of **B.C.K.V, Mohanpur, Nadia**
 - The earnest money of the unsuccessful Bidder(s) will be refunded from the office of the Works department concerned with the work, after he / she / they is / are to apply for the same, giving the reference to the work, NIT No., date of Tender, amount and mode of Earnest Money deposited – all in a complete form.
