The entire cost of the above produces as would be offered by the party and duly accepted by the authority will have to be paid to the concerned In charge against demand draft, within 7 days from the date of acceptance of the tender. Other wise his "Earnest Money / Security deposit will be forfeited.
4. The non seed produces must be collected by the party at his own cost.
5. The tender along with requisite " Earnest Money "as specified below must be submitted for the above mentioned produces within the last date given below with out Earnest Money / tender will be treated as cancelled.


