The tender in sealed cover is hereby invited from bonafide parties for disposal of Mango fruits at RRS, Jhargram Farm (Agroforestry project) (in the ensuing season i.e. 2020 upto 30th June 2020).

RRS, Jhargram Farm(Agroforestry project).

i) Mango trees - 493 Nos. (only fruits) Minimum rate of Rs. 1,10,601/- (one lac ten thousand six hundred one only)

Intending parties may see the above mentioned fruits in the said farm on any working day within 7.00 a.m. and 12.00 noon after making prior appointment with the above mentioned Farm.

Each party has to abide by the terms and conditions mentioned hereunder and any breach, abrogation of the same will automatically lead to cancellation of tender and forfeiture of " Earnest Money / Security Money".

1. The rate must be ex-field and without any container.
2. The rate to be submitted by the party must be written legibly both in figure and in words on a plain sheet duly singed along with detailed mailing address & Mobile No.
3. The above mentioned fruits must be collected by the party at its own cost.
4. Pruning and damage of branches of the plants would not be allowed during intercultural operation & harverting.
5. No liabilities of any theft of fruits or damaged of fruits would be borne by the University after the acceptance of tender.
6. Maintenance & cleaning of above mentioned trees and field will be done by the party. Other wise your tender is cancelled.
7. The decision of the authority in any case is final.
8. The Earnest Money has to be deposited either by cash or draft. Incase of cash , the whole amount has to be deposited to the Farm Manegar, Jhargram Farm before the tender closed.

The tender for mango fruits grown in the above mention farms must be submitted accompanied with an " Earnest Money/Security deposit " of **Rs.5000/- (Five thousand)** only each respectively and it must be paid against demand draft to be drawn in favour of " BIDHAN CHANDRA KRISHI VISWAVIDYALYA", payable at UBI, BCKV, or SBI, Kalyani branch.
