Tender is hereby invited from bonafide parties for disposal Cashew Nut (for the ensuing seasons i.e. 20-21 upto July 2020) of Research plot Jhargram Farm, Midnapore (West). Intending parties may see the above mentioned produce in the said farm on any working day within 7.00a.m. and 12.00 noon after making prior Appointment with the concerned Farm Manager.

Each party has to abide by the terms and conditions mentioned hereunder and any breach abrogation of the same will automatically lead to cancellation of tender and forfeiture of "Earnest Money/Security Deposit".

1. The rate must be ex-Tree and without any container.
2. ID proof having permanent address and mobile no. for communication has to be submitted with the tender quotation.
3. The entire cost of the above produce as would be offered by the party and duly accepted by the authority will have to be paid to the concerned Farm Manager within 10 days from the date of acceptance of the tender.
4. The tender along with requisite ' Earnest Money 'as specified below must be submitted for the above produce within the last date given below.
5. Cashew Nut will be taken from the following trees for research purpose.
6. **Beside the above, 200 kgs. matured, bold and quality seeds will be harvested by the Project personnel for raising seedling for grafting**
