Tender is hereby invited from bonafide parties for lease out of the ponds at Teaching Farm, Mondouri in BCKV, Mohanpur, under the terms and conditions failing which the tender will be deemed as cancelled and the "Earnest Money/ Security Deposit" will be forfeited.

**Teaching Farm - 14 nos. ponds Nos ponds. (small ponds area approx 15.273 bigha & big ponds area approx 102 bigha)**

**The "Security Deposit/ Earnest Money" for the ponds is Rs. 60,000/- (sixty thousand) only.**

**The last date lease out period of ponds 31.12.2023.**

Intending parties may see the above mentioned ponds in the said farms on any working day within 7.00 a.m. to 12.00 Noon. after making prior appointment with the Farm Incharge, Teaching farm, in BCKV, Mohanpur, Nadia.

4. The authority may take water from the said pond or may use the water of pond at any time, if need be.
5. Erection of hut and cultivation of vegetable at the embankment of the said water bodies is strictly prohibited.
6. The decision of the authority in any case is final.


