Tender is hereby invited from bonafide parties for lease out of the ponds at Balindi Research Complex in BCKV, Mohanpur, under the terms and conditions failing which the tender will be deemed as cancelled and the "Earnest Money/ Security Deposit" will be forfeited.

**Balindi Farm – 04 Nos ponds**

**The "Security Deposit/ Earnest Money" for the pond is Rs. 50,000/- (fifty thousand) only.**  
**The last date lease out period of ponds 31.12.2023.**

Intending parties may see the above mentioned ponds in the said farms on any working day within 7.00 a.m. to 12.00 Noon. after making prior appointment with the Farm Incharge, Balindi farm, in BCKV, Mohanpur, Nadia.

Each party has to abide by the terms and conditions mentioned hereunder and any breach, abrogation of the same will automatically lead to cancellation of tender and forfeiture of "Earnest Money / Security Deposit".

5. Erection of hut and cultivation of vegetable at the embankment of the said water bodies is strictly prohibited.
