### Tender NOTICE

The tender in sealed cover is hereby invited from bonafide parties for disposal of mosambi (in the ensuing season i.e. 2020-21) up to 30<sup>th</sup> September 2020 of Jhargram Farm (Research plot).

#### Jhargram Farm (AICRP on Agroforestry).

i) Mosambi - 550 nos. trees (only fruits)

Intending parties may see the above mentioned fruits in the said farm on any working day within 7.00 a.m. and 12.00 noon after making prior appointment with the Farm Incharge, Jhargram farm.

Each party has to abide by the terms and conditions mentioned hereunder and any breach, abrogation of the same will automatically lead to cancellation of tender and forfeiture of "Earnest Money / Security Money".

1. The rate must be ex-field and without any container.
2. The rate to be submitted by the party must be written legibly both in figure and in words on a plain sheet duly singed along with detailed mailing address, Mobile no.
3. Intercrops may be cultivated during the tender period.
4. The fruit must be collected by the party at its own cost.
5. Every harvesting be done in presence of Agroforestry staff.
6. Harvesting of all fruits must be completed sharply at the end of September 2020, so that next intercrop may be sown in the first week of October 2020.
7. Collection of one fruits sample from each bearing plant, collection of soil samples from plots and intercultural operations within the experimental plots will be done by the project personal during tender period.
8. Care must be taken to avoid any loss or damage of farms properties including standing trees and if there be any loss or damage, the entire liabilities will have to be borne by the party.
9. The tender along with requisite "Earnest Money" as specified below must be submitted for the above mentioned fruits within the last date given below.
10. The desision of the authority in any case is final.
11. The Earnest Money has to be deposited either by cash or draft. Incase of cash, the whole amount has to be Deposited to the Farm Incharge, Jhargram Farm before the tender closed.

The tender for fruits grown in the above mention farms must be submitted accompanied with an "Earnest Money/Security deposit" of **Rs.5000/-** (five thousand) only each respectively and it must be paid against demand draft to be drawn in favour of "BIDHAN CHANDRA KRISHI VISWAVIDYALYA", payable at UBI, BCKV, or SBI, KALYANI branch or through cash.

Tender must be addressed to the Director of Farms, BCKV, Mohonpur, Nadia, PIN-741252, so as to reach him by **18<sup>th</sup> May 2020. At 3.00 p.m.** The envelope must be super scribed as "**TENDER FOR mosambi OF Jhargram Farm (Research plot).**"
