## NOTE

This is for clarification of the false and fabricated news published about the cancellation of accreditation and students sufferings that, the university already communicated with the ICAR long back regarding the compliances about newly introduced system responding in a positive vibe till date. Though accreditation is accorded till March 2021 we received in 18<sup>th</sup> November 2016, which was effective from March 2016. The process of accreditation for next five years should have been started in 3<sup>rd</sup> quarter of 2020 which has been started late due to COVID pandemic.

Few newspapers published false report that BCKV may lost its accreditation which has the intention to defame and malign the image of BCKV as SAU and ICAR as well. BCKV is an ICAR accredited SAU which is renewing it for further five years as per the ICAR norms with no possibilities of loosing accreditation. This is an attempt with malafide intension to discourse the normal administrative and academic atmosphere of this Viswavidyalaya by some group for their vested interest which is witnessed in the past.

The process of compliance to new accreditation has been taken from January 2021 and the steps for accreditation in online mode have been taken in consultation with competent authority of ICAR. In BCKV, the accreditation process is in last stage where, Letter of Intent (LoI), Institutional Eligibility for Accreditation (IEA) and Statement of Compliance (SoC) has been done successfully on 28<sup>th</sup> June 2021 (BCKV accreditation Application ID: AUCycle3300-000-1180494868-2021) and ICAR acknowledged the online application (Vide F.No. 1/63/2021-EQR/Edn dated 21<sup>st</sup> July 2021). Accordingly, the Self Study Report (SSR) is on the verge of completion under process which will be uploaded along with the accreditation charge of Rs. 6.0 Lakhs+ 18% GST very within the time frame allotted.

As per the notification of the ICAR (copy attached), the students will not suffer in any way for pending accreditation and they can avail all the academic assignment and entrance examinations for PG and PhD admission in the SAUs where the accreditation is in process.

BCKV administration strongly condemn these false propaganda.

**PUBLIC NOTICE-AMENDMENT**

It is for the information of candidates aspiring to appear in ICAR's AIEEA (PG) and AICE-JRF/SRF(Ph.D.)-2021 examination that the extant eligibility requirements for admission through these examinations already notified vide Public Notice No. 1(6)/2018-Exam Cell-Part (IV) dated 24<sup>th</sup> June, 2021 with respect to the requirement of ICAR accreditation stands partially modified as under:

*"In case of those UG and PG students who were admitted in various degree programmes, either by the AUs or through ICAR All India Entrance Examination, if the programme already had ICAR-NAEAB accreditation, but in the passing out year or at any stage in between could not be accredited by the ICAR due to any reasons, one time chance is being given to them for appearing in ICAR's All India Entrance Examination (Academic Session 2021-22) for PG and Ph.D. admissions".*

Rest of the content in Public Notice dated 24<sup>th</sup> June, 2021 (visit: [www.icar.org.in](http://www.icar.org.in)) remains unchanged.
