In cancelling of Previous Tender No. FAG/RD-870 dated: 23.05.2020, sealed rate quotations are hereby invited from the interested resourceful experienced caterers for running the Cafeteria at Bidhan Chandra Krishi Viswavidyalaya, Mohanpur, Nadia from 06.00 a.m. onwards on all working days using kitchen, dining, electricity, supplied water. The floor area of Cafeteria is 26.30m x 84.40 m . The rental charge should be quoted in per month basis. The details terms and conditions are as follows.

### Terms and conditions:

The Tender shall contain the quoted rate per month for running the Cafeteria using the kitchen, dining, electricity, supplied water etc. along with a Bank Draft of Rs. 2,000.00(Rupees two thousand) only as earnest money in favour of Bidhan Chandra Krishi Viswavidyalaya, SBI, Kalyani branch code 1082 and copy of trade license

The Successful bidder shall be permitted to run the Cafeteria for a term of 03(three) years on leased basis, by an agreement and it may be extended on satisfactory performance assessed by a committee constituted for the purpose later on. At any time the authority may terminate the contract by giving one month prior notice without giving any explanation to vendor. The leased value/rent to be paid in advance for each month by the successful bidder. The meal / tiffin to be served by Cafeteria on rate to be fixed after prior approval of the committee concerned.


1. The proportionate charges on consumption of electricity at the Bidhan Chandra Krishi Viswavidyalaya, Mohanpur, Nadia to run the Cafeteria to be borne by the successful bidder and be deposited in every month.
2. The successful bidder shall maintain cleanliness, hygiene and others safety measures from his side.
3. Any internal decoration in the Cafeteria, if required, may be allowed after prior approval of the appropriate authority.
4. The Successful bidder shall have to deposit Rs.25,000.00 (Rupees twenty five thousand) only as security money on bank Draft in favor of Bidhan Chandra Krishi Viswavidyalaya, SBI, Kalyani branch code 1082 (refundable on expiry of the terms as per agreement).
5. The interested bonafide vendors/parties are requested to quote their rates in sealed cover and submit the same in the drop box maintained at the Registrar Dept. for the purpose to the undersigned on or before 8<sup>th</sup> November, 2021 .

10. The minimum rate to be quoted is 10000.00 per month.


