The tender in sealed cover is hereby invited from bonafide parties for disposal of **non seed lathyrus** at RRSS, Chakdah farm.

RRSS, Chakdah

a) Non seed Lathyrus - 27 Quintals (approx)

Intending parties may see the above mentioned non seed lathyrus in the said farms on any working day within 7.00 a.m. and 12.00 noon after making prior appointment with the concerned farm Incharge.

Each party has to abide by the terms and conditions mentioned hereunder and any breach, abrogation of the same will automatically lead to cancellation of tender and forfeiture of "Earnest Money / Security Deposit".

1. The rate must be ex-godown and without any container.
2. The rate to be submitted by the party must be written legibly both in figure and in words on a plain sheet duly singed along with detailed mailing address & Mobile No. & photo copy of photo ID proof.
3. The entire cost of the above Lathyrus as would be offered by the party and duly accepted by the authority will have to be paid to the concerned Incharge against demand draft or cash, within 7 days from the date of acceptance of the tender. Other wise his " Earnest Money / Security deposit will be forfeited.
4. The non seed lathyrus must be collected by the party at his own cost.
5. The decision of the authority in any case is final.
