Intending parties may see the above mentioned produce in the said farm on any working day within 7.00a.m. and 12.00 noon after making prior Appointment with the concerned Farm Manager. Each party has to abide by the terms and conditions mentioned here under and any breach abrogation of the same will automatically lead to cancellation of tender and forfeiture of "Earnest Money /Security Deposit".
