The tender in sealed cover is hereby invited from bonafide parties for disposal of Mosambi fruits and Guava fruits at Jhargram Farm (Experimental Plot- Agroforestry).

**Jhargram Farm (Experimental Plot- Agroforestry)**

- a) Mosambi fruits - 355 trees Nos. (approx) (only for fruits)  
b) Guava fruits - 60 trees Nos. (approx) (only for fruits)

Intending parties may see the above mentioned fruits at Jhargram farm on any working day within 7.00 a.m. and 01.00 P.m after making prior appointment with the Manager Incharge, above Farms.

Each party has to abide by the terms and conditions mentioned hereunder and any breach, abrogation of the same will automatically lead to cancellation of tender and forfeiture of " Earnest Money / Security Money".

1. The rate must be ex-tree and without any container.
2. ID proof having permanent address and mobile no. for communication has to be submitted with the tender quotation.
3. The fruit must be collected by the party at its own cost.
4. No liabilities of any theft of fruits or damage of fruits would be borne by the University after the acceptance of tender.
5. The tender along with requisite " Earnest Money "as specified below must be submitted for the above mentioned fruits within the last date given below.
6. Pruning and damage of branches of the experimental plants would not be allowed during intercultural operation & harvesting.
7. The decisions of the authority in any case is final.
8. The Earnest money has to be deposited through draft.
