
1. The rate must be ex-godown and without any container.

The entire cost of the above item as would be offered by the party and duly accepted by the authority will have to be paid to the concerned Incharge against demand draft or cash, within 7 days from the date of acceptance of the tender. Other wise his " Earnest Money / Security deposit will be forfeited.
4. The non seed items must be collected by the party at his own cost.
