Marigold fresh flowers (orange variety, compact, free from disease pest and any discoloration, initial moisture content not less than 90%)	66 tons	Marigold fresh flowers (orange variety), good quality (without any browning and rotting) to be supplied on regular basis at fixed price within 6 months, preferably to be purchased from the farmers of Ranaghat II block to maintain varietal conformity. Total flowers may be supplied at 3-4 batches at Processing centre of the present project at Ranaghat-II or any other nearby places specified by the PI. All costs are inclusive of all taxes and transportation cost applied.

Terms & Conditions:

- (i) The bona fide and eligible bidders who are either registered as “Farmers’ Producers Organisation (FPO)/Farmers Producers Company (FPC)/ Promoter of minimum three FPO-s or FPC-s” are requested to quote their price. Relevant documents along with incorporation certificates etc. are to be submitted to prove the eligibility criteria.
- (ii) EMD of Rs.68,000/- (Rupees sixty eight thousand only)of the total amount quoted amount is to be uploaded through Demand Draft in favour of Bidhan Chandra Krishi Viswavidyalaya, along with the quotation. Without EMD quotations will not be considered for financial comparison. EMD exemption certificate must be submitted with the quotation document, if any.
- (iii)The bidders should have I.T Return (last three years), current trade license, GST related certificates and PAN etc. In case of GST exemption, supporting documents should be provided.
- (iv) The bidders should have prior experience in marigold flower trading involving the farmers (At least 50 in number) of Nadia District, (To be supported by Work orders, completion certificate, list of Farmers with contact number etc.)
- (v) **Work orders may be given phase wise (4-5 phases) and order may be increased/decreased up to 25%, subject to availability of fund.** Next level order will only be given upon successful completion of previous order.
- (vi) In any case, specification will not be compromised
- (vii) Upon supply of any inferior material will be rejected and deducted from the payable amount and in extreme case work order may be cancelled. The buyer will not be responsible for deduction in payment/ cancellation of work order due to quality and quantity issues. The quoted price should be inclusive of all taxes, if any. The rates should be quoted per unit basis inclusive of all taxes and transportation cost, loading, unloading etc. which should be mentioned clearly.
- (viii) Quotations must specify the terms and conditions mentioned above (point number i to vii) for supply of marigold fresh flowers which have precisely been put together.
- (ix) The University reserves the right to reject or accept any quotation without assigning any reason what so ever.
