The tender in sealed cover is hereby invited from bonafide parties for Lease out of **Banana trees (Only fruits)** at C.R. Farm, Gayeshpur, BCKV. Last date of tender period is **31st December, 2023**.

C.R. Farm, Gayeshpur, BCKV

- a) Banana Tree - 800 Nos. (approx) (Only for fruits)**
(Kathali - 600 Nos. + Green Banana - 200 Nos.)

Intending parties may see the above mentioned item in the said farms on any working day within 7.00 a.m. and 12.00 noon after making prior appointment with the concerned farm Incharge.

Each party has to abide by the terms and conditions mentioned hereunder and any breach, abrogation of the same will automatically lead to cancellation of tender and forfeiture of "Earnest Money / Security Deposit".

1. The rate must be ex-godown and exfarm.
2. The rate to be submitted by the party must be written legibly both in figure and in words on a plain sheet duly signed along with detailed mailing address & Mobile No. & photo copy of photo ID proof.
3. The entire cost of the above items as would be offered by the party and duly accepted by the authority will have to be paid to the concerned Incharge against demand draft or cash within 7 days from the date of acceptance of the tender. Otherwise his "Earnest Money / Security deposit will be forfeited.
4. The fruits must be collected by the party at his own cost.
5. Maintenance & cleaning of above mentioned trees and field will be done by the party. Otherwise your tender is cancelled.
6. Pruning and damaging of branches/ trees of the experimental plants would not be done during harvesting.
7. The decision of the authority in any case is final.
