The tender in sealed cover is hereby invited from bonafide parties for lease out of Mango tree (only fruits) at Teaching farm, Mondouri for **02 (Two) years**. Last date of tender period **31st July, 2024**.

1. The rate must be ex-godown and exfarm.

The entire cost of the above items as would be offered by the party and duly accepted by the authority will have to be paid to the concerned Incharge against demand draft or cash within 7 days from the date of acceptance of the tender. 5. Maintenance & cleaning of above mentioned trees and field will be done by the party. Otherwise your tender is cancelled.
6. Pruning and damaging of branches/ trees of the experimental plants would not be done during harvesting.
