**RE-TENDER FOR HIRING A SMALL VEHICLE**

The College of Agriculture, Burdwan Sadar, Dist-Purba Burdwan, an extended Campus of Bidhan Chandra Krishi Viswavidyalaya invites sealed quotations in own letter head from reputed transporters / vehicle owners for quoting rates on monthly dry basis for hiring a small commercial vehicle (Diesel, 4+1-seaters), initially for one year & may be extended for another year after satisfactory performances, including 24 hours service driver with valid driving license (commercial) not less than five years and also the driver should be competent enough to maintain log book in proper manner as prescribed by the authority and also immaculately maintain the vehicle. The vehicle should be used for 24 hours and must garage within the campus. The college will provide fuels and lubricants. The car should have the capacity to run long distances and stay overnight outside and also use as an emergency hospital duty. The vehicle must be fitted in all respect as per RTO rules like pollution certificate, insurance coverage, road permit etc.

The interested parties may quote their rates per month in dry basis along with a xerox copy of demand draft worth Rs.2,000/- in favour of BCKV and payable at SBI, Kalyani Central Park Br. with clearly mention the road mileage and lubricants. All other expenses except fuel, lubricants & dry monthly charges shall be borne by the owner itself. During repairing, servicing works etc. of the vehicle, alternative arrangement shall be made by the owner also. Selected transporter/ owner shall enter into a contract agreement with the university in a hundred rupees non-judicial stamp paper.
