The sealed quotations are hereby invited from bonafide parties for lease out of Mango and Coconut orchard (only fruits) and a pond at College of Agriculture, BCKV, Burdwan Sadar **for three years only i.e. 01.04.2023 to 31.03.2026**. The interested parties may visit the site within 13.02.2023 to 28.02.2023 (week days only) between 11.00 am to 4.00 pm. The last date of submission of tender paper is 28.02.2023 at 4.00 pm sharp.

- Mango orchard (Only fruits) - 60 No of Trees (Appx.)
- Coconut Orchard (only fruits)- 60 No of Trees(Appx.)
- One Pond Size 100 meter X 100 meter (Appx)

Intending parties may see the above mentioned Pond, Mango & Coconut Trees (only fruits) in the said farms on any working day within 11:00 am to 4: 00 pm after making prior appointment with Assistant Registrar or Associate Dean of the college.

Each party has to abide by the terms and conditions mentioned hereunder and any breach, abrogation of the same will automatically lead to cancellation of tender and forfeiture of "Earnest Money/ Security Deposit"

- The rate must be ex-godown / ex-farm.
- The rate to be submitted by the party must be written legibly both in figure and in words separately for ponds, mango & coconut orchard on a plain sheet duly signed along with detail mailing address & Mobile number & xerox copy of a photo ID proof.
- The entire cost of the above items as would be offered by the party and duly accepted by the authority will have to be paid to the college through demand draft within 7 days from the date of acceptance of the tender, otherwise his " Earnest Money/ Security deposit" will be forfeited.
- The fruit must be collected by party at his own cost.
- Maintenance & clearing of above mentioned pond, trees and field will be done by the party with his own cost.
- Pruning and damaging of branches / trees of the experimental plants would not be done during harvesting.
- The decision of the authority in any case is final.


