4. The selected person/party have to deposit entire quoted amount at a time at the office of Hooghly KVK, Chinsurah, Hooghly within seven (7) days of issuing the order.
5. The selected person/party will only get Mango fruits from the leased plants upto the specified period.
6. The selected person/party will not be vested any right of any other materials like plant parts, land, etc. except mango fruits.
7. The field may be used by the KVK office for demonstration and practical class purposes during exposure visit or farmers visit programme.
8. The selected person/party has to look after the entire fields of mango during the leased tenure. KVK will not be responsible for any theft, loss due to natural calamities, disease pest attack, etc.
