- Regarding terms & conditions it may kindly mentioned that 50 kg (Fifty Kg only) matured, bold and quality seeds will be harvested by the farm staffs of Jhargram farm for raising seedling for grafting.
- The applicant has to apply online in <wbtenders.gov.in> portal.
- 2. At the time of applying online in <wbtenders.gov.in> portal, the applicant has to download the specified Application format and after filling up the format completely, the same has to be scanned and scanned copy should be uploaded in the "Application folder" (in .pdf format).
- The Applicant has to upload scanned copy of self attested photocopy of his/her Aadhaar Card in the "Aadhaar Card" folder while applying online in (in .pdf format).
